(i) Land rear of Mitford allotment

31/25 Town & Country Planning Act 1990

Members considered planning application 23/02188/FUL Covered riding arena, 20m x 40m for personal use, steel framed building with grey fibre cement roof, green metal box profile cladding above concrete panels: Blue Cedars Paddock, Tranwell Cottages, Tranwell NE61 6AE

RESOLVED

Mitford Parish Council expresses concern in relation to the potential visual impact of this development on neighbouring properties and from the road. The development also appears to contribute to sporadic growth within the Green Belt. Additionally, the Parish Council request that a condition be imposed to restrict the use of the development to private use only, not commercial use.

32/25 <u>Morpeth Neighbourhood Plan Review</u>

Councillor Sharp advised members that the Government has taken the decision to cut funding and technical support for Neighbourhood Planning groups. Currently there is no further information, and it is a case of wait and see.

33/25 <u>Highways</u>

(i) Mitford Speed Sign

Members were informed that no response has been received from Northumberland County Council regarding the siting of speed strips previous data on the western approach to Mitford

(ii) <u>Tranwell Woods Traffic Speed Sign</u>

No further update.

(iii) Tranwell Gateway

Members were advised that the Parish Council is now in possession of the location key and will look at the speed data in the next few months. The Mitford Gateway Scheme is still at the design stage.

(iv) Land Slippage B6343 (Abbey Mills)

Members were advised that a meeting is taking place on 27th June regarding the upcoming work. Councillor Sharp is attending this meeting. Work to repair the landslip is set to get underway mid-August for approximately 39 weeks. A diversion for cars will be put in place via St Leonard's Lane, while HGV's will divert via the B6524. Traffic lights will be placed on the south end of St Leonard's Lane and improvement works will be carried to St Leonard's Lane and the C149 road to Mitford Steads in readiness.

A pedestrian diversion will be put in place that runs parallel to the south of the road, although it will not be suitable for pushchairs or mobility scooters.

Can the verge opposite the church be properly paved as concerns have been raised about emergency vehicles passing through when the church is busy?

Will the diversions routes be made mandatory as concerns were raised that these will be ignored?

34/25 Village Hall

Members were advised that the funding is progressing for the resilience project. The allocation of the funding will be £14k to NCEL and £6k to the village hall for a generator and associated costs. The next stage will be for a lease agreement to be put in place between the village hall and NCEL. The work should be carried out in this financial year.
