- (i) Land rear of Mitford allotment

Councillor Sharp advised members that he is still awaiting a response from the Environment Agency regarding permits and advice from the geomorphologist. The Environment Agency had previously advised that a group of trees growing out of the bank

immediately upstream could be pulled down into the river and pinned into place to break up the water, and this would not require permitting.
